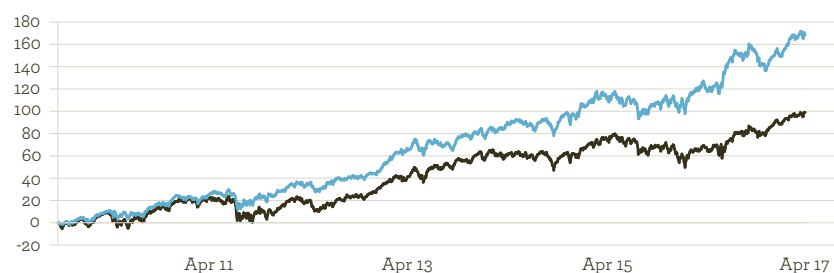
MANAGER COMMENTARY

April was a mixed month for global stock markets, with geopolitical news flow providing many of the talking points (a snap UK general election, the French presidential election, the US administration's corporate tax plans, North Korean tensions etc.).

Evenlode rose +1.1% compared to -0.4% for the UK market and +1.5% for the IA UK All Companies Sector. Positive fund contributors included WS Atkins, Pagegroup and Sage. Atkins rose +39% after receiving a recommended takeover approach from Canadian peer SNC-Lavalin. As a relatively small company with a strong competitive position in the global engineering consultancy market, Atkins has always looked like a potential participant in sector consolidation. The offered price is not embarrassingly low but even so we will be sad (assuming the deal is consummated) to see this 'hidden champion' disappear from the UK market. Pagegroup confirmed solid trading and strong cash generation continues, whilst Sage shares recovered somewhat after a weak start to 2017. Since the month end, Sage has reported interim results that demonstrate good progress on new products, healthy cash generation and a dividend increase of +9%. The main negative contributors were GlaxoSmithKline, Astrazeneca and Procter & Gamble. All three companies released first quarter results and though they reiterated full year guidance, performance wasn't helped by the pound's rise against the dollar (following the announcement of the UK general election).

In terms of portfolio changes, we trimmed the fund's holding in WS Atkins following the share price rise. We also completed a staged exit from MITIE - we think new management's strategy is sensible but have exited on balance sheet considerations. In terms of additions, we introduced a new holding in UBM, a market leader in the global trade exhibition industry. This is a sector we know well (UBM's two largest global peers are divisions of Relx and Informa, also Evenlode holdings) and produces several desirable economic characteristics including high barriers to entry, good revenue recurrence and strong cash generation. UBM offers a dividend yield of 3.3%, and we see attractive potential for long-term growth in free cash flow and dividends.

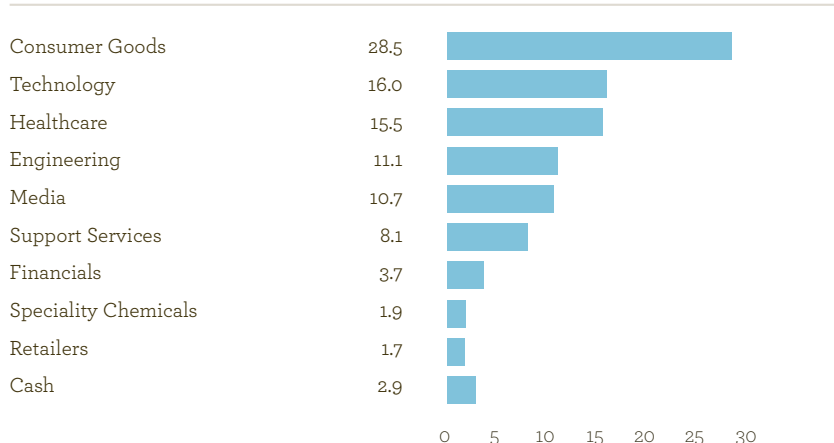

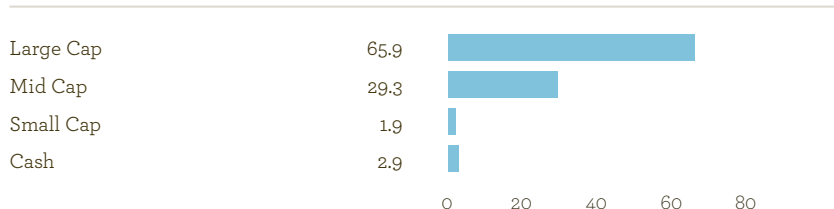

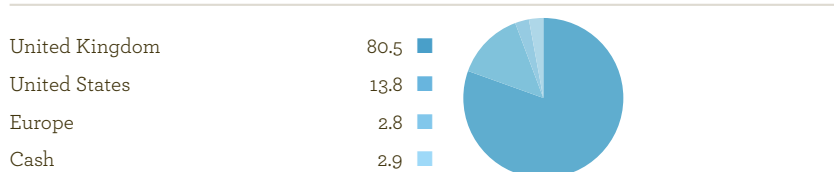
SECTOR ALLOCATION (%)
